
### BATTERY REMOVAL AND INSTALLATION INSTRUCTIONS

IN HOW TO INSTALL BATTERIES: 1. Open the battery door with a screwdriver, 2, If used batteries are present, remove these batteries from the unit by pulling up on one end of each battery. DO NOT remove or install batteries using sharp or metal tools. 3. Install new batteries as shown in the polarity diagram (+/-) inside the battery compartment, 4. Replace battery door securely, 5. Check your local laws and regulations for correct recycling and/or battery disposal.



#### BATTERY SAFETY INFORMATION: Batteries are

small objects. Replacement of batteries must be done by adults. Follow the polarity (+/-) diagram in the battery compartment. Promptly remove dead batteries from the toy. Dispose of used batteries properly. Remove batteries for prolonged storage. Only batteries of the same or equivalent type as recommended are to be used. DO NOT incinerate used batteries. DO NOT dispose of batteries in fire, as batteries may explode or leak. DO NOT mix old and new batteries or types of batteries (i.e. alkaline/standard/rechargeable). Using rechargeable batteries is not recommended due to possible reduced performance. Rechargeable batteries are only to be charged under adult supervision. Replaceable-rechargeable batteries are to be removed from the toy before being charged. DO NOT recharge non-rechargeable batteries. DO NOT short-circuit the supply terminals.



Requires 3 x 1.5 V AAA batteries (included). Batteries or battery packs must be recycled or disposed of properly. 
